### Instructions for Accepted Work

- Work must be professionally ready for hanging (wired).
- Use plexy glass only, glass accepted for pastel work.
- Sculpture: 35lb limit (our pedestals are 12” x 12”)
- **Delivery Instructions:**
  - Hand deliver or ship work to gallery
  - When shipping, **do not use peanuts.**
  - Send work with pre-paid bar coded return label
  - (UPS or Fedex preferred). No US postal stamps.

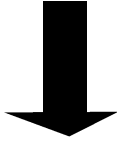
